Use of foreign brand names in domestic market

3185. SHRI GHUFRAN AZAM; Will the PRIME MINISTER be pleased to state:

(a) whether the PUD Chambers of Commers and Industry has urged Government to reconsider its decision on the use of foreign brands in the domestic market;

(b) whether the decision to use foreign brands in the domestic market would lead to the virtual closure of a wide range of Indian industries;

(c) if so, the reaction of Government thereto; and

(d) the steps Government propose to take to save the Indian industries from collapse?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (DEPARTMENT OF INDUSTRIAL DEVELOPMENT) (SHRIMATI KRISHNA SAHI): (a) This Ministry is not aware of any such representation of the PHD Chamber of Commerce & Industry. Further, the PHD Chamber, has confirmed in writing that it has not made any written suggestion to the Government on the use of foreign brand names.

(b) to (d) Government has decided not to place any restriction on the use of brand names/trade marks, whether foreign or Indian owned, in India provided these do not violate any statute, rules or regulations in this country. This is expected to augment industrial growth in the country.
