Central University at Tezpur in Assam

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) The Government of India have taken a decision, in principle, to set up a second Central University in Assam at Tezpur.

(b) and (c) Action is being taken to introduce a Bill during the current Monsoon Session of Parliament.

Opening up of more central schools in Uttar Pradesh

3389. SHRI SHANTI TYAGI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) what is the number of students admitted in the Kendriya Vidyalaya in the State of Uttar Pradesh during this academic Session;

(b) what is the total capacity of these Central Schools in Uttar Pradesh;

(c) whether Government propose to expand some of the schools and also open some more schools in view of the large number of candidates seeking admission in the State and also in view of the large size of the state, and

(d) if not, what are the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) Admissions are still continuing and the number of admissions is not finally known as yet

(b) The total number of students in Kendriya Vidyalayas of Uttar Pradesh on 30.4.91 was 97098. It is difficult to indicate any specific capacity as the Education Code of the Kendriya Vidyalayas envisages admissions over and above the normal class strength for certain circumstances.

(c) and (d) The sanction of additional section, and upgradation of Kendriya Vidyalayas is a continuous process. In the Kendriya Vidyalayas Sangathan, Kendriya Vidyalayas are opened, subject to the availability of resources, where there is a concentration of Central Govt. employees and the proposals are sponsored by the authorised agency which agrees to provide 15 acres of land and temporary accommodation free or on nominal cost and 50 per cent residential accommodation to the staff of the Kendriya Vidyalaya.

(a) whether it is a fact that the Indian Council of Historical Research has decided to shelve the project 'Towards Freedom' which was started in 1973;

(b) if so, what are the reasons therefor;

(c) what is the total number of volumes that were to be published and how many have been brought out till date;

(d) what was the total budget allocated for the project and how much of it has been utilised;

(e) whether Government propose to monitor the utilisation of the funds and pinpoint the responsibility for delay, misutilisation and abandoning the project; and

(f) if so, what action is contemplated to be taken against such persons?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) No, Sir.

(b) Does not arise.

(c) Ten volumes were to be published out of which only one volume has been brought out till date.

(d) The total expenditure incurred on the project for 1972-73 to 1991-92 comes to Rs. 218.53 lakhs against budget provisions made on yearly basis.

(e) The delay in completion of the project occurred primarily because no full time editor could be appointed till 1982, which severely limited the selection and editing of material during the first nine years. The Government has issued guidelines to Indian Council of Historical Research to ensure that all the volumes should be published by 31st March, 1994 and in no case shall the publication of any volume be delayed beyond 31st March, 1997. The funding of the Project by Government of India ended on 31st March, 1992.

(f) The question does not arise.
