कल्याण मंत्री (श्री सीताराम केसरी) :
उत्तर प्रदेश में 1978-79 से 1991-92 तक पुस्तक बैंक योजना के अंतर्गत, 9231 अनुसूचित जाति तथा अनुसूचित जनजाति के छात्र लाभान्वित हुए ।

(ख) इस योजना के अंतर्गत 1991-92 के दौरान केंद्र का 2 लाख रुपए का हिस्सा राज्य सरकार को निर्मुक्त कर दिया गया है ।

Utilisation of Water of over flowing rivers

Will the Minister of WATER RESOURCES be pleased to state:

(a) whether Government propose to connect water of all the overflowing rivers and pool it up for utilisation during the lean season; and

(b) if so, what are the Government plans in this regard?

THE MINISTER OF WATER RESOURCES (SHRI V. C. SHUKLA): (a) and (b) A National Perspective

for Water Resources Development prepared by the Government envisages inte-linkages between the major rivers of the Peninsular region and between the Himalayan rivers separately for transfer of water from water rich basin to water deficit basin, for optimum utilisation of water resources. The National Water Development Agency (NWDA) under the Ministry of Water Resources has been entrusted the work of firming up these proposals.

Facilities provided by Project Authorities

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) the details of the facilities which the different Project Authorities are required to extend to the employees of Kendriya Vidyalaya sponsored in Project-Sector; and

(b) whether these facilities are being extended?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) The employees of the Kendriya Vidyalayas set-up in the project sector are employees of the Kendriya Vidyalaya Sangathan, governed by the same terms and conditions of service as their counterparts in other Kendriya Vidyalays. However, for setting up a Kendriya Vidyalaya in the Project sector, the project authorities are required to provide residential accommodation to such employees, as a pre-condition for opening the Vidyalayas.
