As of now, there is no proposal to hand over hospitals to a private agency. Some of the hospitals in Maharashtra have a lower bed occupancy due to shifting of industrial population. The ESIC is planning reorganisation of the existing infrastructure.

Industrial Training Institutes function under the administrative and financial control of State Governments / Union Territories (UTs). Providing of posts at various levels, the recruitment of incumbents and maintenance of reservation roster is the responsibility of the respective State Governments / UTs. These data are not maintained by Central Government.
