## CBI. Inquiry into the Misappropriation case

3346. SHRI MANMOHAN MATHUR: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to refer to the answer to Unstarred Question 4132 given in the Rajya Sabha on the 27th March, 1992 and state:

- (a) whether the official involved in the misappropriation case has been identified;
- (b) if so, what action has been taken against him;
- (c) whether Government propose to order a thorough enquiry into all projects/schemes handled by the said official to unearth such misappropriation of funds; and
- (d) whether Government also propose to instruct the authorities not to hand over projects/schemes involving use of Government funds to the said official to prevent misappropriation of funds in future?

Contribution of all sections of the society is welcome. The present strategy is for Total Literacy Campaign. Sucn campaigns are area-specific, time bound. volunteer-based, cost-effective and outcomeoriented. An area can be a village or a cluster of villages, a village panchayat or a mandal panchayat, panchayat samiti or block, a district or even a State. Irrespective of the geographical denomination of the area, a proposal for total literacy in a campaign mode\* must emanate from the grass root level with the active encouragement, concurrence and support of the State Government and the District Administration. Proposals received are considered by the Executive Committee of the National Literacy Mission Authority for approval The National Literacy Mission Authority also provides academic and technical resource support for formulation
