#### **Development of Live Stock and Dairy in Rural Areas**

3298. SHRI SOM PAL:

DR. NAUNIHAL SINGH:

Will the Minister of AGRICULTURE be pleased to state:

(a) whether Government propose to launch a special plan for development of livestock and a dairy in rural areas;

(b) if so, what are the details thereof and how much investment is proposed under these plans during the Eighth Plan period;

(c) whether it is a fact that restrictions on processing of milk and dairy

products are hampering the growth of dairy in our country; and

(d) if so, whether Government propose to delicensing dairy industry in tune with its latest policy of introducing free market forces in other spheres of economy?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI K. C. LENKA): (a) and (b) The animal husbandry and dairying activities are mainly concentrated in the rural areas of the country. For the development of this sector various central and centrally sponsored programmes are being implemented/proposed to be launched during the 8th plan period. These programmes include improvement of genetic breed of animals, fodder development, health cover, processing and marketing of livestock products. An amount of Rs. 400 crore for livestock development and Rs. 900 crore for dairy has been earmarked for the 8th plan.

(c) and (d) No, Sir. The items "milk foods" and "malted foods" were delicensed under the New Industrial Policy announced by the Government on 25th July, 1991. However, with a view to maintain and increase supply of liquid milk of desired quality in the interest of the general public, the Government has issued the milk and Milk Product Order on 9th June, 1992 providing for regulating the production supply and distribution of milk and milk products.
