Government, there have been instances of ineligible persons in unauthorised occupation of such residences. During the course of inspections during the last one year, 345 cases of unauthorised occupation were detected. Such inspectons are continuing process.

(b) In case any unauthorised occupation of the government residence is proved after following the due procedure, action to evict the unauthorised occupants is taken under the Public Premises (Eviction of Unauthorised Occupants) Act, 1971. During the last one year action was taken to evict 41 unauthorised persons from govt, residences.

Assistance for development of urban centres

3442. SHRI V5THALRAO MADHAVRAO JADHAV: WiU the Minister of URBAN DEVELOPMENT be pleased to state:

- (a) what is the special financial assistance is being provided to tackle the problems of developing urban centres of the country;
- (b) whether the special central assistance ig provided to tackle the problems of Bombay city;
- (c) whether it is a fact that State Government of Maharashtra has represented before the Eighth Finance Commission t_0 make a special grant of Rs. 1000 crores for tackling the problem_s of Bombay; and
- (d) if so, what action has been taken thereon?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI M. ARUNA-CHALAM): (a) "Urban Development" is a State subject. The Ministry of Urban Development, in the Government of India, plays only a nodal role and has no discretionary funds/special funds for allocation to the State Governments. It is, for the State Govts/UTs to formulate suitable proposals with a view to obtain-

ing suitable allocation through the State Annual Plans

(b) The then Prime Minister India during his visit to Bombay in connection with the Centenary cele brations of the AH India Congress Committee (I) in 1935 announced a special grant of Rs. 100 crores to the Govt, of Maharashtra to solve the acute problems of slums and housing in Bombay. A sum of Rs. 88 Crores stand released to the Govt, of Maha rashtra. In addition, the Ministry of Finance on the recommendation of the 9th Finance Commission' sanc tioned a one-time grant of Rs. 50 Crores to the Government of Maha rashtra for slum clearance, environ mental improvement of slums and provision of 'basic amenities in bay with the condition that the State Govt, would also make a matching provision of the amount for this pur pose. The Ministry of Finance have already released Rs. 48.33 Crores to the Government of Maharashtra.

Besides these grants, World Bank aided Urban Development Projects as well as Bombay Water Supply and sewerage Project at a total cost of Rs. 1115.71 Crores are under implementation. These include projects for Slum upgradation, Sites and Services, Water supply and Sewerage, Storm Water Drainage, Roads, Solid Waste Management and Technical Assistance for training and equipment

(c) and (d) Yes, Sir, the Ninth Fin ance Commission sanctioned a special grant of Rs. 50 crores for 1989-90 with matching contribution from the State Govt.

शहरी किकास मंतालय में राज्य गंती (श्री एम, अरुण जलम्) : (क) से (घ) देश के शहरी क्षेत्रों में भूमियत मलजल निपटान के लिए कोई केन्द्रीय सहायता नहीं है। इसके परिणामस्टब्स् केन्द्रीय सरकार के पास ऐसी योजनाओं के विचाराधीन होने का प्रथन ही उहीं उठता। तथापि, द्विपक्षीय श्रीर बहुपशीय सहायता हेतु प्रस्तुत करने से पूर्व राज्य सरकारें अपनी परियोजना रिपोर्टी को तकनीकी अनुमोदन के लिए भारत सरकार को भेजती हैं।

Hindi officers in C.P.W.D.

3444. SHRI KRISHAN LAL SHARMA: Will the Minister of URBAN DEVELOPMENT be pleased to state:

- (a) the number of Hindi Officers working in various subordinate offices of C.P.W.D. for implementation of official language policy of Government in accordance with the norms laid down by official language Department in 1981 and 1989;
- (b) whether Government have received any representation to promote Junior Hindi Translators working in the subordinate offices of C.P.W.D.;
 - (c) if so; the steps being taken in regard; and
- (d) whether Government propose to form a cadre of such posts in subordinate offices of C.P.W.D. despite repeated instructions of Official Languages Department and if so, when it is likely to be formed?

THE MINISTER OF STATE TN THE MINISTRY OP URBAN DEVE-

LOPMENT (SHRI M. ARUNA-CHALAM).
(a) The post of Hindi Officer/Assistant Director (official Language) is at present not available in the subordinate Offices of CPWD

(b) Yes, Sir.

(c) and (d) A proposal for creation of certain posts in Hindi work in the Subordinate Offices of CPWD has been formulated. A decision on this has hot so far been taken because it involves collection of certain additional information. Promotional avenues for the Junior Hindi Translators would be available only after posts in higher categories are created. The Question of cadre formation will also arise after sufficient number of posts are created.
