Will the Minister of FOOD be pleased to state:

(a) the State-wise statutory minimum cane price and actual cane price paid during 1989-90, 1990-91 and 1991-92;

(b) what is the commission being charged by cane growers cooperative societies at present;

(c) what is the percentage of quality-wise production of sugar during 1989-90 and 1990-91;

(d) what was the State-wise consumption of sugar during 1990-91 (including Defence requirement);

(e) whether it is a fact that many cooperative sugar factories were denied incentive quota in June and July, 1992 when the prices were higher; and

(f) if so, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPPLIES AND PUBLIC DISTRIBUTION (SHRI KAMALUDDIN AHMED) : (a) The State-wise details of statutory minimum cane price and the actual cane price paid during 1989-90, 1990-91 and 1991-92 are given at Statement I. (See below).

(b) Details of rates of Co-operative Societies' Commission, as per reports received, payable in various States during 1991-92 season are given at Statement II. (See below).

(c) Details of percentage of quality-wise production of sugar during 1989-90 and 1990-91 season are given at Statement III. (See below).

(d) Details of State-wise consumption of sugar during 1990-91 season (including Defence requirement) are given at Statement IV. (See below).

(e) and (f) Yes, Sir. The incentive quota of some sugar factories was withheld from June, 1992 onwards for non-submission of utilisation certificates relating to the sugar year 1990-91. This incentive quota is being restored as and when the required certificates are being received.
