## Corruption cases against Director, IIT, Bombay

3376. SHRI AJIT P. K. JOGI: SHRIMATI KAILASHPATI:

- (a) whether it is a fact that the Director of the Indian Institute of Technology, Bombay is involved in several serious cases of corruption, disappropriation of funds and favourtism;
- (b) whether it is also a fact that several people representatives have drawn Government's attention in this regard;
- (c) if so, whether any inquiry has been ordered against the Director of the IIT, Bombay;
  - (d) if so, what are its findings; and
  - (e) if not, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE (KUMARI SELJA):

(a) to (e) The attention of the Government has been drawn by people's representatives towards some charges against the Director of the IIT, Bombay. The matter has been examined in consultation with the Chairman of the Board of Governors of the Institute. It is seen from the factual information and its analysis that there is no substance in the allegations made. The question of instituting an enquiry, therefore, does not arise.
