- (c) The steps being undertaken for control and containment of Malaria include :—
 - (1) Anti-Vector Measures
 - (a) Chemicals methods
 - Spraying with appropriate insecticides like DDT/BHC/Malathion.
 - Weekly application of anti-larval chemicals in water bodies in Urban areas.
 - (b) Biological methods
 - Introduction of larvivorous fishes wherever feasible.
 - (2) Anti-Parasitic Measures
 - Case detection and prompt treat ment with appropriate anti malarials.
 - (3) Personal protection measures by the use of clinically impregnated bednets wherever feasible, being proposed to be undertaken during VIII Plan Period.
 - (4) Comprehensive tribal malaria control campaign in tribal areas of 7 States namely Andhra Pradesh, Bihar, Gujarat, Madhya Pradesh, Maharashtra, Orissa and Rajasthan by using different intervention methods for control of Malaria is being proposed.
 - (5) Intensive health education to enlist active people's participation in malaria control activities.

- (a) the details of facilities available in R. M. L. Hospital, New Delhi for C.G.H.S. beneficiaries;
- (b) the names of C. G. H. S. Specialist Doctors at present in the Hospital day-wise;
- (c) whether it is a fact that the pressure of work on these specialists has increased and the present facilities have become inadequate to cater to C. G. H. S. beneficiaries;
- (d) if so, whether Government propose to expand these facilities in major Hospitals in Delhi/appoint more specialists in more C. G. H. S. Dispensaries;
 - (e) if so, the details thereof; and
- (f) if not, the reasons therefor and in what manner Government propose to meet the situation?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI D. K. THARA DEVI SIDDHARTHA): (a) The Services available to CGHS beneficiaries and general public in R.M.L. Hospital are in the specialities of Medicine, Surgery, Orthopaedics, Gynae. & Obst., Dental, Skin, Psychiatry, Physiotherapy, E. N. T., Eye, Neuro-Sur-gery, Plastic Surgery, C. C. U. etc. However, entitled CGHS beneficiaries are provided Nursing Home facilities free of cost except diet charges. All diagnostic tests are done free for CGHS beneficiaries. Medical and Surgical Departments run separate O. P. D. for Central Government Health Scheme beneficiaries.

- (b) A list is attached as Statement (See below).
- (c) There is a network of dispensaries which are adequately covered by specialist* services through 31 nodal dispensaries and 2 nodal centres.

(d) and (e) At present there is no proposal to appoint more Specialists in CGHS Dispensaries. To provide enchanced coverage and greater facilities, the State Government and local bodies hospitals, Railway

and Army hospitals and a few private hospitals in Delhi have been recognised for CGHS beneficiaries for taking treatment in all specialities.

(f) The question does not arise.
