Hike in Steal Prices

*59. SHRI YASHWANT SINHA: SHRI KRISHNA KUMAR BIRLA:

Will the Minister of STEEL be pleased to state:

- (a) what is the percentage increase effected in steel prices recently as compared to the previous price in crease;
- (b) what are the reasons for the steep hike in the prices of steel;
- (c) what will be its over-all impact on the industry which is passing through a severe recession and on steel consuming units as a whole; and
- (d) in what manner it has affected India's exports based on steel?
- THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SONTOSH MOHAN DEV): (a) The average price increase effected by th'e integrated steel plants from 18th/19th May, 1992 was 15 per cent as compared to 5 per cent in September, 1990.
- (b) The recent increase in price has been to neutralise the increases in costs of inputs on account of coal price, revision, readjustment of rupee value and exchange rate variations, impact of two Union Budgets and two Railway. Budgets, increases in power and water rates, etc.
- (c) The integrated steel plants ac-count for 56 per cent of the total production of finished steel. In respect of the balance 44 per cent of the production, on which there was no price regulation, the price increase has been marginal. Thus, on an overall basis, the present price increase is unlikely to have a significant impact on industry, including steel consuming units.
- (d) Steel used for manufacture of engineering goods for exports is

covered under the International Price Reimbursement Scheme (IPRS), which enables exporters to claim differential between the domestic and international prices. Thus, the report price increase should not affect the exports of steel based products..

Joint Entrance Examination far IITs

- (a) whether it is a fact that in the recent Joint Entrance Examination for the UTs papers for some subjects had more than one correct answers thereby confusing the candidates and making the evaluation difficult;

- (c) what is the result of the inquiry, if any, made by Government into the matter; and
- (d) what action has been taken by Government in this regard?

THE MINISTER OP HUMAN SB-SOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (d) la the recently conducted Joint Entrance Examination for admissions to ITOs and IT-BHU, there was a screening paper, as per established practice, for the sole purpose of shortlisting candidates whose performance in the main papers was to be evaluated in order to prepare the All India Merit List. The screening paper contained objective type questions and the examinees were required to identify the correct answer(s). The evaluation procedure involved preparation of model answers by the paper setters . These model answers were then moderated upon and examined critically by different committees of ex-miners to incorporate all possible cor-

rect answers. The model answers thug moderated upon were then frozen. Evaluation has been done on the basis of these frozen model answers. Full credit was given to the candidates who ticked the required number of correct answers. Full credit was also given to those candidates who ticked any one of the possible correct answers as contained in the model answers. Hence there is no question of any confusion arising in the minds of the candidates while writing the answers. There was absolutely no difficulty in evaluating the answer scripts. The question of conducting any enquiry, therefore, did not arise.
