welfare and upliftment of women in various capacities and fields such as social welfare, trade-unionism, voluntary action, social work, administration and public health.

(b) The Commission was constituted on January 31, 1992. Since its inception the Commission has held inquiries into cases of atrocities against women and processed 300 complaints regarding the harassment of women. It has held meetings with women Members of Parliament, representatives of voluntary organisations, women professionals in the media etc. The Chairperson Members have participated in several programmes for women in different States, Action has been taken to constitute Committees for review of specific legal provisions and for special studies as prescribed under the Act.

Family Welfare and population control education at School Level

 - (b) if so, the details thereof; and

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION ANDDEPART-MENT OF CULTURE) (KUMARI SELJA): (a) and (b) Realising education in tackling potential of problems of growing population, a National Population Education ject (NPEP) was launched with effect from April 1980 designed to introduce population education in the formal Subsequently, education system. NPEP was divided into three parts, and Non-formal namely (i) School Education (ii) Adult Education and (iii) Higher Education Under the Population Education (School and Non-formal Education) Project, the population education elements are being integrated into the school syllabi and textbooks.

The conceptual framework of population education is primarily based on the following six themes:—

- (i) Family Size and Family Welfare.
- (ii) Delayed Marriage.
- (iii) Responsible parenthood.
- (iv) Population Change and Resource Development.
- (v) Population Related beliefs and values.
- (vi) Status of Women.
- (c) Does not arise.

Amount allocated for adult education in the Eighth Plan

- (a) what was the amount spent on Adult education during Seventh Plan and what are its achievements; and
- (b) what is the amount allocated for adult education during Eighth Five Year Plan?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELIA): (a) An expenditure of Rs. 469.57 crores (central and state sectors taken together) was incurred on the adult education programme during the Seventh Plan period. During this period, 384.03 lakh persons were reported to have been enrolled under the programme.
