public at large and what would be its like cost when introduced in the market?

THE MINISTER OF HEALTH AND FAMIL WELFARE (SHR I M. (a) to (c) The Indian FOTEDAR): Institute of Science, Bangalore and the Institute for Research in Reproduction, Bombay have been carrying out research on the role of Vitamin Carrier Protein in the maintenance of pregnancy. These studies have, so far. been carried out on animals . The initial results indicate that by neutralising protein carrier, the from Vitamin Rivoflavin is prevented reachning the foetus causing foetal degeneration and death. As such, the process may have potential for contraception or pregnancy termination.

Toxicity studies to determine the side effects of the process will have to be undertaken after results of the initial studies are well established. In view of the preliminary nature of the studies so far undertaken, the queston of public use of the method does not arise at this stage.

# Implementation of recommendations of Bal Krishnan Committee

- \*515. SHRI SUBRAMANIAN SWA-MY: Will the Minister of HOME AF-FAIRS be pleased to state:
- (a) whether Government have received any memorandum from some political parties in Delhi demanding for the implementation of Bal Krishnan Committee's recommendations about three separate corporations in Delhi;
- (b) if so, what are the details thereof;
- (c) what is Government's reaction thereto?

THE MINISTER OF HOME AF-FAIRS (SHRI S. B. CHAVAN):

(a) to (c) The Committee on the Re-organisation of Delhi Set-up known as Balakrithnan Committee had observed that with the large increase in the population of Delhi and its distribution in far-flung areas, the Municipal Corporation of Delhi has become un-wieldy, unmanageable and unable to give satisfaction to the public. It, therefore, recommended the setting up of separate compact municipal authorities, at convenient locations, each of which should be autonomous in its area to enable it to attend to the needs of the people in that area.

The re-structuring of Municipal poration of Delhi was discussed 17.6.1992 with the leaders of varions political parties and Members of Parliament from Delhi. On behalf of Congress-I party the view was evpressed that any division of the existing Corporation of Delhi would lead multiplicity authorities and insurof mountable difficulties in marters coordination of various subjects relating to provision of civic amenities. representatives of CPI and Janta Dal were also of the view that there should a unified civic set-up with one Municipal Corporation. On behalf of the Bartiya Janta Party, however, urged that the constitution of bodies should be left to the Legislative Assembly rather than to the Central Government. In any case, there should at least be four Municipal Corporations in place of the existing Municipal poration of Delhi i.e. East Delhi, North Delhi, South Delhi and Rural Delhi Corporations.

3. The question of re-structuring of the civic bodies in Delhi is under consideration of Government.

#### Dandakaranya project

\*516. DR. SHRIKANT RAMCHAND-RA JICHKAR; Will the Minister of HOME AFFAIRS be pleased to state;

- (a) the expenditure annually incurred on the Dandakaranya Development Scheme during the last three years;
- (b) what are the various schemes which are being implemented; and
- (c) by when these schemes are likely to be completed?

THE MINISTER OF HOME AFFAIRS (SHRI S. B. CHAVAN); (a) During each of the years 1989-90, 1990-91 and 1991-92 expenditure of Rs. 237,99 lakhs, Rs. 149.77 lakhs and Rs. 65.12 lakhs respectively was incurred.

(b) and (c) The Pottern Irrigation Project in Orissa is under execution. It is likely to be completed by 1996. As its revised project estimates are yet to be sanctioned, Central expenditure under the Dandakaranya Scheme during the three years has been only on making good the deficiences identified in the assets of the Dandakaranya Project, already trasferred to the States.

## Assistance from Asian Development Bank for Coal Handling Project at Paradip Port

- (a) whether the Asian Development Bank has offered any assistance for the implementation of the Coal Handling Project at the Paradip Port; and
- (b) if so, what are the details there-of?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE. TRANSPORT (SHRI JAGDISH TYTLER): (a) Yes, Sir.

(b) Asian Development Bank have expressed their willingness to provide a loan of \$ 285 million for Paradip-Emore Coal Transportation Project which includes \$ 134.85 million for creation of mechanised coal handling facilities at Paradip Port.

### Operation of RETINITIES PIGMEN-TESA

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether Government are aware of successful operation of RETINITIES PIGMENTESA by the doctors of Apollo Eye Institute Hyderabad;

- (b) if so, what is the percentage of success of this operation;
- (c) whether there is any proposal under Government's consideration to start this kind of operation at Dr. Rajendra Prasad Centre for Ophthelmic Sciences, New Delhi;
  - (d) if so, by when; and
- (e) if not, what are the reasons therefor?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI M. L. FOTEDAR); (a) to (e): Refinition Pigmentosa is a hereditary disease leading to abnormal pigmentation of the ratine. The Apollo Eye Research Institute, Hyderabad has been offering medial and surgical treatment for this disease designed at a Medical complex at Moscow; they nave claimed significant improvement in about 25 per cent of the cases treated by them.

The Dr. Rajendra Prasad Centre for Ophthalmic Sciences of AlIMS, New Delhi has no proposal to introduce a similar line of treatment as according to them no published data in English is available covering the technical aspects of operation of its success rate.
