carried out by the Botanical: Survey of India, only 21 species of Orchids found in North-Eastern Region are endangered and are listed in the Red Data Books of Indian Plants. The list of these Orchids is given in the Statement. (See below)

- (c) The remedial steps taken include the following:
 - (i) Ban on international trade and commerce in respect of endangered species in accordance with, the Convention on International Trad© in Endangered Species of Fauna and Hone (CITES), of which India is a party since 1976.
 - (ii) Enforcement of the Wild life (Protection) Act, 1972, which after the amendment of 1991, include some endangered orchid species, and which now provides strict penalties for infringement.
 - (iii) Expansion of the network of protected areas in the North-Eastern region from 3 National Parks and 15 Sanctuaries in 1980 to 9 National Parks and 34 Sanctuaries in 1992.
 - (iv) Tissue culture and other multiplication techniques for conservation and propagation of orchids in National OrChidaria/Experimental Gardens of the Botanical Survey of India at Yer-caud, Shillong—Barapani and Howrah.
 - (v) The State Forest Departments of Arunachal Pradesh and West Bengal have established orchidaria at Tipi—Bhalukpong and Tagda near Kalimpong respectively, for research and propagation of orchids. The State Forest Department of Sikkim has two orchid sane tuaries at Deorali and Saramsa for con. servatiGn of orchids.

THARA DEVI SIDDHARTHA): (a) and (b) Government has approved a Child Survival and Safe Motherhood (CSSM) pro-gramme with an outlay of Rs. 853.61 crores during the VIITTH Five Year Plan, The World Bank, through an agreement executed on 20-2-1992, have committed to provide Interantional Development As-sociation (IDA) financial assistance to the tune of Special Drawing Rights (SDR) 160.90 million (Rs 557.70 crores) for this Programme.

- 2. The Programme aims at reducing maternal and child mortality by integrating and strengthening the existing Univer-

sal Immunization Programme, Oral Rehy_ dration Therapy Programme and the prophylaxis schemes for control of anaemia among pregnant women and prevention of blindness due to Vitamin A deficiency in children. In addition, the Acute Respiratory Infections Control Programme will be implemented in a phased manner throughout the country, including the iNorth Eastern and Eastern States like Bihar, Orissa and West Bengal, as part of the Child Survival initiative to prevent deaths due to pneumonia.

3. The Safe Motherhood component of the Programme has been initiated primarily in States like Bihar and Orissa which have high infant and maternal mortality. The Programme includes intensified training and involvement of Traditional Birth Attendants in ante-natal, natal and posi-tnatal care and strengthening of the Sub-Centres and First Level Referral Units in terms of equipment and training.
