SHAN-KARANAND); (a) Gujarat is the only State on the Western Coast which is producing hydrocarbons, having established geological reserves of 195.4 billion QU. mts. of gas approx. The gas produced therein during the years 1989-90, 1990-91 and 1991-92 was approx, 1613, 1697 and 1898 million cu. mts. respectively.

(b) The major scheme being imple- mented to exploit the potential is Gandhar phase-II.
