

Requirement of Electricity in the country

Will the Minister Of POWER be pleased to state:

(a) whether Government have done any survey about the approximate monthly or yearly requirement of electricity of the country for the next five years;

(b) if so, what are the details thereof; and

(c) in what manner Government propose to meet the demand of electricity in the country?

THE MINISTER OF STATE OF THE MINISTRY OF POWER (SHRI KALP NATH • RAI): (a) and (b) Yes, Sir. The energy requirement of the country for the year ending 1996-97 would be 416274 million units and peak demand would be 73656 MW.

(c) In order to mitigate the power deficit in the country, various measures taken to improve the availability of power in the country included -expediting commissioning of new generating capacity, implementation of -short gestation projects, improving the 'performance of existing power statione reduction of Transmission ana Distribution losses, implementation of demend management and energy conservation measures and arranging transfer of energy from surplus to deficit areas. The capacity addition target for the 8th Plan has been kept at .30065 MW.

Electricity transmission line projects of Madhya Pradesh

(a) whether it is a fact that four elec tricity transmission line projects of Madnya Pradesh are pending clearance with the 'Central Government;

(b) if so, what are the details thereof; and

(c) by when Government propose to give clearance to these transmission line projects?

THE MINISTER OF STATE OF THE MINISTRY OF POWER (SHRI KALP NATH RAI): (a) to (c) The transmission schemes associated with Korba Unit 5-6 and Static Var Compensation Project of M.P have been techno-economically approved by Central Electricity Authority.

The VIIIth Plan transmission works and those associated with Gopad TPS (4x500 MW), Bina TPS (4x250 MW) and Birsingpur TPS (Stage-II) are under techno-economic appraisal of CEA in consultation with the State Government.
