conducted by the Board in Delhi in 1992. The decision regarding the use of multiple sets of question papers has been reviewed by a committee specially set up by the CBSE for this purpose. The committee found the scheme effective and educationally sound. The committee has also concluded that academically the use of multiple sets will induce the teachers to improve their teaching methodology and the students of study their course-in full since in this system the paper setter is likely to cover the entire syllabus.

Use of narcotics in educational
