Poor Result of XIIth Exam of CBSE

941. SHRI KRISHNA KUMAR BIRLA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to refer to the answer to the Unstarred Question 301 given in the Rajya Sabha on the 10th July, 1992 and state:

(a) whether it is a fact that the result of the CBSE examination declared recently has shown poor pass percentage in Class XIIth of Govt. Schools in Delhi;

(b) if so, what is the percentage of decline in the pass percentage during the last three years, year-wise;

(c) whether Govt. propose to have a thorough review of the Govt. school system in Delhi to identify the causes for poor performance; and

(d) if so, what steps have been taken by Government in this direction?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) Yes, Sir, in so far as the Government Schools run by the Delhi Administration are concerned.

(b) During the three year period of 1989-92 the pass percentage of Government Schools run by Delhi Administration in the Senior School Certificate (Class XII) examination conducted by the CBSE has declined by the annual rates of 10.8 per cent in 1990, 13.6 per cent in 1991 and 3.0 per cent in 1992.

(c) and (d) Yes, Sir. As per the information furnished by the Delhi

Administration, a Committee is proposed to be constituted by the Lt. Governor of Delhi.

Funds to Delhi University

942. SHRI KRISHNA KUMAR BIRLA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether Government's attention has been drawn to news item captioned "U.G.C. cut in grants hits varsity plans" which appeared in the Hindustan Times dated 28th June, 1992;

(b) if so, whether the University Grants Commission has cut down in grants to Delhi University;

(c) whether due to cut in grants, the expansion plan of the Delhi University has been affected at large;

(d) if so, the details of grants University Grants Commission made available to Delhi University during the last three years; yearwise; and

(e) the steps Government propose to take to provide adequate funds to University Grants Commission to meet the financial requirements of various Universities?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) Yes, Sir.

(b) to (e) Central Universities are fully funded by the Central Government through UGC. Keeping in view the present constraints on the availability of financial resources, Central Government has decided to maintain the level of non-plan expenditure of all Ministries/Departments and Autonomous Bodies during 1992-95 at the level of last year.
