(e) what further steps have been taken by Government to check smuggling of kids to Arab countries for camel races?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF YOUTH AFFAIRS AND SPORTS) WITH ADDITIONAL CHARGE OF MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF WOMEN AND CHILD DEVELOPMENT) (KUMARI MAMTA BANERJEE): (a) to (d) On 21-6-92, detection by the alert Immigration officials led to arrest of two Bangladeshi Nationals at Indira Gandhi International Airport Delhi. The cases were registered under Section 419/420/468/471/365/367/373/120 B-IPC and under Section 14 Foreigners Act against the accused persons. It transpired that the person who had arranged for the visit of the accused was

involved in sending the children from India and other neighbouring countries to Gulf countries for the purpose of Camel racing.

(e) The Govt. is aware of this problem and will take suitable steps to prevent it.
