#### **New\* C. B. S. E. Scheme for examination**

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) and (b) In order to control mass copying and minimise the use of unfair means in the Examinations conducted by the Central Board of Secondary Education (CBSE), the Board decided to use multiple sets (four in number of Question papers during the 1992 Secondary (Class X) and Senior Secondary (Class XII) Examinations in the Union Territory of Delhi. The different sets of Question Papers were prepared by the same paper setter. All the sets were homogenous in standards and identical in patterns and difficulty level.

The multiple sets have achieved the desired objective because there was not a single incident of mass copying in the Class X and Class XII Examinations
