THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA):  
(a) According to the information furnished by U.G.C., the following State Universities have been established during the last two years:

The Deccan College Post-graduate and Research Institute, Poona; Jain Visva Bharati Institute, Ladnun (Rajasthan) and the Bengal Engineering College, Sivpur and Forest Research Institute, Dehradun were notified as Deemed to be Universities.

The legislation has been enacted to establish Central Universities at Sii-char in Assam and at Lumami in Naga land. It has also been agreed, in principle, to establish a second Central University in Assam.

(b) The enrolment of students in faculties of Arts, Commerce and Science is 39.5 per cent, 19.5 per cent and 22.8 per cent respectively. According to the information furnished by the UGC, the Commission has not allocated any targets of enrolment between different faculties.

(c) According to the information furnished by UGC, the Commission has no proposal under consideration for bifurcating the Commerce faculty at the first degree level.

(d) Yes, Sir, Utkal University has been established under an Act of State Legislature of Orissa and, as a matter of policy, the Central Government do not convert State Universities into Central Universities.

#### Funds for vocational education to Madhya Pradesh

928. SHRI GHUFRAN AZAM: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether Government in order to promote vocational education in the country has allocated special funds to the States and Union Territories during the current financial year;

(b) if so, what are the details thereof;

(c) what are the details of the funds allocated to the Madhya Pradesh for this purpose;

(d) whether Government propose to provide more funds to Madhya Pradesh to open more vocational institutes in the State; and

(e) if not, the reasons therefor?

**THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA):** (a) and (b) Under the Centrally Sponsored Scheme of Vocationalisation of Secondary Education at +2 level funds are released to the State Governments/UT's on receipt of proposals indicating their requirement. A few proposals have been received during the current financial year and these are being examined.

(c) to (e) An amount of Rs. 31.48 crores has been released to the Govt. of Madhya Pradesh from the year 1987-88 to 1991-92 under the scheme. The State Government have not yet fully utilised the funds released so far. Further expansion of the programme in the State would be considered when the unspent funds are substantially utilised.

#### बनारस हिन्दू विश्वविद्यालय

929. श्री सत्य प्रकाश मालवीय : क्या मानव संसाधन विकास मंत्री यह बताने की कृपा करेंगे कि :

(क) क्या सरकार को इस बात की जानकारी है कि बनारस हिन्दू विश्वविद्यालय में छात्रों के लिए छात्रावास, पुस्तकालय, वाचनालय, चिकित्सा, पठन-पाठन और भोजन की सुविधाएँ अपर्याप्त हैं और निम्न स्तर की हैं; और

(ख) यदि हाँ, तो उनमें सुधार करने के लिए क्या उपाय किये जा रहे हैं।

मानव संसाधन विकास मंत्रालय (शिक्षा विभाग और संस्कृति विभाग) में उपमंत्री (कुमारी शैलजा) : (क) और (ख) छात्रावास की बढ़ती मांग को पूरा करने के उद्देश्य से बनारस हिन्दू विश्वविद्यालय ने 7वीं योजना के दौरान 312 महिलाओं के लिए अतिरिक्त

आवास का निर्माण किया है। 8वीं योजना के दौरान विश्वविद्यालय अनुदान आयोग द्वारा 100 लाख रुपए का आवंटन किया गया है ताकि विश्वविद्यालय महिलाओं के लिए छात्रावास को और अधिक बढ़ाया जा सके।

बनारस हिन्दू विश्वविद्यालय द्वारा भेजी गई भूचर्चा के अनुसार महिला महाविद्यालय में दिए जाने वाले भोजन के स्तर के संबंध में शिकायतें थीं। इन पर ध्यान देते हुए विश्वविद्यालय ने मार्च, 92 में कालेज में सहकारी भोजनालय को बंद कर दिया और उसके स्थान पर उके पर भोजनालय को एक पद्धति शुरू की, जो बताया जाता है कि सुधारत्मक है।

वि०अ०आ० ने पुस्तकों और पत्रिकाओं की खरीद के लिए विश्वविद्यालय को 7वीं योजना के दौरान 48 लाख रुपए और 8वीं योजना के दौरान 100 लाख रुपए का आवंटन किया है।

विश्वविद्यालय ने सूचित किया है कि विश्वविद्यालय के छात्र स्वास्थ्य केन्द्र में चिकित्सा अधिकारियों के रिक्त-पद भरने के लिए उपाय किए गए हैं।
