(b) and (c) The interaction envisaged between the Armed Forces of India and the US include exchange of visits, participation in training programmes, and Seminars-Symposia. A joint Naval training exercise was also conducted recently between two ships each of the Indian and US Navies off the Western seaboard of India.

Our Armed Forces personnel interact with their counterparts of many other countries through a structured process which contributes towards confidence building and in enabling the Indian Armed Forces to upgrade their professional abilities.
