Smuggling of Petrol and Kerosene

4328. SHRI RAJNI RANJAN SAHU; SHRI VIRENDRA KATARIA: DR. ABRAR AHMED.

Will the Minister of FINANCE be pleased to state;

(a) whether there have been any increase in the incidents of smuggling *of* fuel such as petrol and kerosene by LTTE terrorists from Tamil Nadu to Sri Lanka; (c) what steps have been taken by Government to cheek the smuggling?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI RAMESHWAR THAKUR): (a) and (b) Customs authorities have detected cases of smuggling of petroleum pro-ducts by smugglerslfishermen from the coast of Tamil Nadu to Sri Lanka, The quantify and petrol, kerosene, diesel and other value of petroleum products seized by Customs authorities during the last 3 years are given in the table below. However, since smuggling is a clandestine activity, it is not possible to say whether such smuggling of fuel has increased.
