Life span of railway tracks in the country

4523. SHRI S. S. AHLUWALIA: Will the Minister of RAILWAYS be pleased to state:

(a) what is the normal average life span of railway tracks in the country after it is laid and used for railway traffic;

(b) the details of the railway track in Bihar which has outlived the prescribed time-limit and still being used for rail traffic;

(c) whether Government propose to in the State; and

(d) if so, the details thereof and if not, replace such rail tracks in the near future the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) The average service life of railway tracks is taken as 20 years to 40 years depending upon the density of traffic and other related environmental conditions.

(b) to (d) Railway tracks are being kept in "SAFE CONDITION" by maintenance or renewals as required.

It is planned to undertake renewals on BG on the railway system during the VIII Five Year Plan on condition basis and availability of funds. The renewals on MG will, however, be restricted to only the stretches where the same are required on safety considerations as the important routes are being taken up for conversion to BG under the uni-gauge policy.
