- (b) whether it is a fact that 200M.W. gasbased power plant of Utrari is laying idledue to non-availability of gas?

THE MINISTER OF PETROLEUM AND GAS (SHRI B. SHANKARA-NAND); (a) The offer has not been fund feasible, as the gas from the Hazira Gas Terminal is already committed to various consumers ex-Hazira and along the HBJ pipeline.

(b) An Action Plan has been prepared to expedite supplies to the second unit of the Uttaran power station. However, this is subject to GEB signing the Gas Supply Contract, and clearing (lie arrears due to ONGCIGAIL.
