Emission of pollutant gases by travancore Titanium products

4383. SHRI SOM PAL:

DR. NAUNIHAL SINGH:

Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) whether it is a fact that pollutant gases emitted by the Travancore Titanium Products are beyond permissible limits:
- (b) what is the permissible limit of such gases and what is the actual quan tum of gases being omitted by the unit;
- (c) what aution is proposed to be taken against the company?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH): (a) and (b) Sulphur dioxide emissions at times exceed the limit from the sulphuric acid plant of Travancore Titanium Products, even though a Double Conversion Double Absorption system has been Permissible limit for sulphur adopted. dioxide from an acid plant is 1500 milligrams per normal cubic metre. Occasional excessive emission upto 2700 milligrams per normal cubic metre has been observed from the unit in the last two years. Excessive emissions occur for quarter of an hour during start up.

(c) The Kerala Pollution Contro! Board has directed the Travancore Titanium Products to replace the existing acid plant with a new one of 300 tons per day capacity with an extra catalyst bed and a start up scrubber, and with an on line sulphur dioxide monitor. The unit has also initiated work on installation of pollution control measures which includes a combination of 14 digestor stacks and raising the height of 26 stacks from the digestor, boiler, calciner, grinding mill and spray drier to 25 metres, as in the acid plant.

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH): (a) The total recorded forest area in the per the State of Forest country as Report 1991' is 770078 Sq. Kms.

- (b) The State-wise break-up of the forest area in the country is detailed in the Statement, (See below).
- (c) No specific land is carmarked for afforestation. However, afforestation is done largely in degraded forests and also along roads, canal banks, railway lines, and public fields bunds and private wastelands as per the availability funds.
- (d) and (e) A massive programme of afforestation including Social and Farm Forestry under the 20 Point Programme is under implementation in all the States/ Union Territories. During the VIIth Five Year Plan 8.88 million hectares brought under afforestation and in the Eighth Five Year Plan, there is a proposal to cover an area of 18 million hectares under forest/tree cover, at a proposed outlay of Rs. 9950 crores,
