Study conducted by the Nutrition Foundation of India

- 4424, SHRIMATI KAMLA SINHA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:
- (a) whether it is a fact that the Nutrition Foundation of India has conducted a study commissioned by WHO⁵ and FAO;
- (b) whether it is also a fact that the study has brought out new problems on nutrition front and various nutritional disorders caused by consumption of food products and cereals produced by intensive une of Chemical fertilisers; and
 - (c) ill so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI D. K. THARA DEVI SIDDHARTHA):

(a) to (c) WHO have recently published a book "Nutrition in Develop-' mental Transition in South East Asia" written by Dr. C. Gopalan, Director, "Nutrition Foundation of India. According to this book intensive cropping with the use of high analysis fertilisers could result in substantial micronutrient losses of sulphur, iron, manganese, zinc and copper.

The book also mentions that both soils and crops in many areas of Andhra Pradesh., Punjab and Haryana are deficient in zinc. These soils are also reported to show deficiencies with respect to iron and manganese but of a lower order.

M.B.B.S, Doctors in rural areas

4425. SHRI S. S. SURJEWALA: Will the Minister of HEALTH AND FAMILY WFLFARK be pleased to state:

- (a) whether Government are aware that the MBBS and other specialised doctors are not prepared to serve in the Rural areas on account of life style and lack of facilities in Rural Areas resulting into the suffering of millions of people and resulting into about 90 per cent Rural Hospital/Health Centres and dispensaries functioning without qualified doctors;
- (b) if so, whether Government propose to start a new two year middle Rung condensed course for the doctors supposed to serve in Rural areas so that this population is not deprived of the medical facilities; and

(ii) to (c) Government have already recommended to State Governments that it should be made compulsory for all doctors jo'ning government service to serve in rural areas for two years. The recommendation was circulated to all concerned and as per available information some State Governments have made

il obligatory for doctors to serve in rural areas when they join service; some States have obtained bonds from medical students to serve in rural areas after graduation. There is no proposal to start a condensed course for doctors to serve in rural areas.

The posts in the rural hospitals and health centres are filled by the State Governments directly. According to the information available with the Government, vacancies of medical officers in the Primary Health Centres were about 14..! per cetn al the beginning of 1992.

Villages covered under village Health Guide Scheme

4426. SHRI SATYA PRAKASH MALA VIVA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state-

- (a) what is the number of districts not yet covered by the Village Health Guide Scheme, State-wise:
- (b) what is the criteria for selection of Village Health Guides and the remunerations being paid to them;
- (c) whether any assessment has been made about the commensurable achieve ments of the scheme against the expen diture incurred since its inception; and
 - (d) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY *OF* HEALTH AND FAMILY WELFARE (SHRIMATI D. K. THARA DEVI SIDDHARTHA)- (a) The Village Health Guide (VHG) Scheme is being implemented in all States and Union Territories, except Arunachal Pradesh, Delhi, Goa. Daman and Diu. Jammu and Kashmir, Kerala and Tamil Nadu. The Central Government does not maintain district-wise records of V.H.Gs.

- (b) The VHG is a voluntary worker selected by the village community. He/she should preferably be about 30 years of age. He/she must be literate and preferably have formal education upto Clas_s VI. The VHG is paid an honora rium of Rs. 50/- per month.
- (c) and (d) No study has been un dertaken with a view to assessing the achievement of the scheme commensurate with the expenditure incurred on the scheme from the date of its inception. However, the last evaluation of the scheme was undertaken in 1984. The evaluation revealed that the scheme was largely accepted by the community and was found to be essentially sound.

Appointment of doctors
