MINISTER OF STATE OF THE THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTA TION AND THE MINISTER OF MINISTRY STATE IN THE OF NON-CONVENTIONAL ENERGY SOURCES (SHRI SUKH RAM): (a) and (b) Basic macro parameters for the Eighth Plan have been estimated at 1991-92 prices. The Plan emphasises the need for reasonable price stability. The dis-savings of the Government have increased in the recent years.

(c) It is envisaged to reduce Government dis-savings; by increasing Government receipts and moderating the rise in Government expenditures. Measures taken in the Central Budget are in line with this approach. Through prudent fiscal and! monetary policies and management of production and distribution the Eighth Plan would attempt to keep the inflation at the lowest possible level.
