National Pharmaceutical Institute in Punjab

591. SHRI JAGIR SINGH DARD: SHRI VIRENDRA KATARIA:

Will the PRIME MINISTER be pleased to state:

(a) whether there is any proposal under Governments consideration to set up a National Pharmaceutical Institute in Punjab in the near future.

(b) whether a site has been selected for the purpose; and

(c) if so, by when the work is likely to be started and completed?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI CHINTA MOHAN): (a) Yes, Sir.

(b) Yes, Sir, at SAS Nagar, Mohali, District Ropar, Punjab.

(c) A conceptual Master Plan has been finalised. A turnkey construction contract has been awarded to the National Buildings Construction Corporation (NBCC), a public sector enterprise. The construction of the project has already started and it is likely to b_e completed by 1994-95.

Approval for Commissioned Programme

Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) whether a number of commissioned programmes for telecast on

Doordarshan have lately been approved by Government;

(b) if so, the details thereof; and

(c) what criteria have been adopted for their approval and what is total amount involved therein?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) to (c) Government does not approve any programme. During 1D92-93, Doordarshan has so far approved 81 proposals under the Commissioned Programme scheme at a cost of Rs. 6,35,95,000 keeping in mind its overall programme requirements.
