M. E. P. /Government to Delhi Administration as the matter requires to be considered in the context of -the incidence of malaria obtaining in different parts of the country.

These studies have proved that same Tibetan medicines are effective in treatment of these diseases. The Council has edited and published one Tibetan manuscript.
