\*227. MAULANA OBAIDULLAH KHAN AZMI: Will the PRIME MIN ISTER be pleased to state:

- (a) whether Government are aw are that due to collusion between cer tain officers of the Super Bazar and the suppliers of various items, sub standard items are supplied to the Super Bazar;
- (b) whether any investigation has been made into the affairs;
- (c) if so, the details thereof and the results achieved: and
- (d) the steps taken to stop the malpractice?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPP LIES, AND PUBLIC DISTRIBUTION (SHRI KAMALUDDIN AHMED): (a) to (c) During the last two years two complaints were received about sup ply of sub-standard items in Super Bazar.

Complaints pertained to supply of substandard quality of Handloom Dusters by M/s. New Central Handloom Cooperative Society. The goods in question were returned to the supplier and further purchases from the supplier Slave been discontinued. The Manager Incharge was shifted from Handloom Department. His explanation is urder examination.

The other case peratins to supply of sub-standard Capsule B-Complex Forte by M/s. Brown Pharmaceuticals Ltd. In this case also the goods in stocks were returned to the supplier and further purchases have been discontinued. The vigilance Department of Super Bazar conducted enquiry and the report is under examination.

(d) Super Bazar is dealing in large number of merchandise. There is a prescribed procedure for purchase

and checking of goods ordered. Whenever a complaint regarding quality comes to notice, necessary action is initiated.

## Delhi fair price shops without essential commodities

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPPLIES AND PUBLIC DISTRIBUTION (SHRI KAMALUDDIN AHMED): (a) and (b) The specified food articles were available at all Fair Price Shops during each of the last six months except the following fair price shops: -

FPS Holder Nos. S246 and 4799 failed to deposit the Demand Draft for supply of commodities mentioned above on the ground that the fair price shops being located in rural area,

there was no demand for the commodity from the consumers, FPS No. 3101 did not remit the Demand Draft for the commodities mentioned on account of the demise of the father of the FPS holder

Regular monitoring of supply and availability of PDS items through fair price shopsi is done by the TJT Administration at various levels in consultation with the agencies involved. The Delhi State Civil Supplies Corporation is entrusted with the task of transpor-ing the PDS items from the godowns of Food Corporation of India (FCI) at the door-steps of the fair price shops. Appropriate remedial/correc-tive action is taken by the UT Administration whenever there is some problem of transportation or labour, to ensure supply of PDS items to the fair price shops.

THE . MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY DEPARTMENT OF ELECTRONICS AND DEPARTMENT OF OCEAN DEVELOPMENT! AND MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS (SHRI P. R. KUMARA-MANGALAM): (a), The VIITth Plan outlay of about Rs-.T75 crores was proposed for Contihuing and 'New

Schemes of Uranium Corporation of India Limited (UCIL), which is a Public Sector Unit under the Department of Atomic Energy. The VIIIth Plan allocation has not yet been flnaiised.

(b) The production from the presently operating mines combined with what would be available from the projects under execution as well as those contemplated during the VIIIth Plan would ensure adequate uranium availability for the planned nuclear power programme of the next ten years. In addition, concerted efforts are continuing for exploration and identification of new sources of uranii-um for economic recovery.
