मानव संसाधन विकास मंत्री [(श्री अर्जुन सिंह): (क) जी, नहीं।

(ख) प्रश्न नहीं उठता।

(ग) उत्तर प्रदेश सरकार ने, यह बताते हुए कि विश्वविद्यालय को बदलने के बाद योजनेतर खर्चे का उनका दायित्व चालू स्तर पर ही निर्झारित दूरहेगा, यह भी इच्छा व्यक्त की कि तीन विश्व-विद्यालय कालेज और एक घटक कालेज विश्वविद्यालय के साथ जारी रहने चाहिए।

केन्द्रीय सरकार को राज्य विश्व-विद्यालयों को केंद्रीय विश्वविद्यालयों में बदलने के लिए समय-समय पर ग्रुनुरोध प्राप्त होते रहे हैं। एक नीति के तौर्द्य पर सरकार ऐसे ग्रनुरोधों को स्वीकार करने के पक्ष में नहीं है।

Mid-day Meal in Schools

*259. DR. NARREDDY THULASI REDDY: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether there is any proposal to include eggs in the mid-day meals for school children;
 - (b) if so, the details thereof; and
 - (c) if not, the reasons therefor?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) There is at present, no concrete proposal to implement a Mid-day Meal Programme for elementary school children throughout the country. However, certain State Govts. are implementing a Mid-day Meal Programme from out of their own resources.

With a view to taking advantage of the increased production of eggs and to provide nutritious and wholesome protein rich food to children, the State Govts. have been requested to consider the inclusion of eggs in the Mid-day-Meal Scheme for school going children.

Construction of Irrigation by-pass Tunnel at Narmada Dam

- (c) whether the Central Government are aware that there are arrears of payment of share cost of Sardar Sarovar Project by the participating States viz Madhya Pradesh, Maharashtra and Rajasthan;
- (d) whether the Central Government propose to take suitable steps in this regard; and
