#### Import of Rice

1676. SHRI MOHINDER SINGH LATHER: Will the Minister of FOOD be pleased to state:

(a) whether Government propose to import rice from Thailand and Vietnam to meet public demand in lieu of export to Basmati Rice; and

(b) if so, the quality and quantity of rice to be imported and the foreign exchange to be incurred thereon?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPPLIES AND PUBLIC DISTRIBUTION (SHRI KAMALUDDIN AHMED):

(a) There is no proposal to import rice from Thailand and Vietnam in lieu of export of Basmati Rice.

(b) Does not arise.

#### Stock of foodgrains of P.D.S.

1677. SHRI SURINDER KUMAR SINGLA: Will the Minister of FOOD be pleased to state:

(a) whether it is a fact that as a result of sharp fall in procurement of foodgrains this year the stocks of foodgrains for the public distribution system (PDS) have depleted putting public distribution system under strain;

(b) if so, what is the net effect of less procurement of foodgrains on the public distribution system;

(c) whether Government are aware that the strain on Public Distribution system is likely to push upward the open market prices of foodgrains; and

(d) if so, what remedial action Government propose to take to contain price of essential commodities?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPPLIES AND PUBLIC DISTRIBUTION (SHRI KAMALUDDIN AHMED):

(a) and (b) On account of lower procurement of both rice and wheat during 1991-92 foodgrains stocks in the Central Pool have come down compared to the position obtaining a year earlier. However, there has been no adverse effect on the public distribution system, releases for which are being made on the normal pattern.

(c) and (d) Open market prices of foodgrains are dependent on the relative position of overall supply and demand of foodgrains in the market. On account of lower procurement this year of wheat and rice, the holding of these foodgrains in the open market is comparatively larger, which should have a sobering effect on the open market prices.
