(c) and (d) The implementation of the Sardar Sarovar Project including the Rehabilitation and Resettlement aspects and Environmental safeguard measures are discussed and reviewed periodically in the meetings of the Sardar Sarovar Construction Advisory Committee & Narmada Control Authority in which the State Governments of Gujarat, Madhya Pradesh, Maharashtra and Rajasthan are represented.
