In so far as Madras is concerned it has not been possible to get the year-vise break-up of HIV incidence amongst the commercial sex workers. The details of the heterosexually promiscuous persons (including commercial sex workers) for the last 3 year; in Madras are as under:

The strategy to prevent AIDS and to reduce the incidence of HIV infection among the high risk groups consists of efforts to raise the basic level of awareness through information, education and communication; upgrading the facilities for diagnosis and management of STD patients, bo h in the private and public sector; promoting increased condom use; and lastly close collaboration with non-government voluntary organisations working in this area. In all these, the effort has been to cover as many heterosexually promiscuous persons as possible and therefore the commercial sex workers, their clients and all other visiting clinics are kept in view for surveillance and intervention.

Upgrading of J.K. Cancer Institute, Kanpur

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI M.L. FOTEDAR): (a) to (d) With reference to a letter sent by us in June, 1991 to the Sta e Governments inviting proposals for district projects for prevention and early detection of cancer under the National Cancer Control Programme, Government of Uttar Pradesh sent a proposal to this Ministry in August, 1991 for upgradation of the J.K. Cancer Institute Kanpur to the level of a Regional Cancer Institute. Reply was sent to the State Government in October, 1991 reiterating or earlier request for submission of proposals for district projects as per the approved scheme under National Cancer Control Programme.
