मदनपुर डैरी फार्म में 276 आवंटितियों में से 6 आवंटितियों ने लाइसेंस शुल्क और शैंड का प्रिमियम जमा कराया है तथा 106 आवंटितियों ने केवल लाइसेंस शुल्क जमा किया है। मसूदपुर डैरी फार्म में 270 आवंटितियों में से 12 आवंटितियों ने लाइसेंस शुल्क और प्रिमियम जमा किया है तथा 32 आवंटितियों ने केवल लाइसेंस शुल्क जमा किया है।

#### Construction of Committee/Boards in the Ministry

2553. SHRI SUBRAMANIAN SWAMY : Will the Minister of URBAN DEVELOPMENT be pleased to state:

(a) the names of the various Committees/and/or Boards at various levels and in the various public sector organisations under the Ministry in which non-officials members from the public are nominated or elected to represent various interests;

(b) the manner in which these Committees and Boards have been constituted and the names and addresses of the members on each of these Committees;

(c) what is the present tenure of the Committees that have been constituted ; and

(d) whether similar other Committees are likely to be constituted?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI M. ARUNACHALAM) : (a) There are four Committees in which non-official members from the public are presently nominated to represent various interests:—

- (1) Rajghat Samadhi Committee
- (2) Shantivan Committee
- (3) Rajiv Gandhi Samadhi Committee
- (4) Babu Jagjivan Ram Memorial Committee.

No non-official is at present nominated on the Board of Directors of the Public Sector Undertakings under this Ministry.

(b) The Rajghat Samadhi Committee is a Statutory Committee constituted under the Rajghat Samadhi Act, 1951 for the adminis-

tration of Rajghat. The Shantivana Committee has been constituted by the Government for looking after the affairs of Shantivana. The Rajiv Gandhi Samadhi Committee has also been constituted by the Government to give necessary directions for to development of the Samadhi of late Shri Rajiv Gandhi. Babu Jagjivan Ram Memorial Committee has been set up for the development of the memorial of Babu Jagjivan Ram in Delhi. The names and the addresses of the members of these Committees are given in the statement. (See below).

(c) The Rajghat Samadhi Committee is a permanent Committee and there is no fixed tenure for the Shantivana Committee and Rajiv Gandhi Samadhi Committee. Babu Jagjivan Ram Memorial Committee will cease to exist as soon as its recommendations are submitted to the Government.

(d) There is no such proposal under consideration at present.
