Grants Commission or Central Government do not seem to have received any information regarding setting up of the Kavi Kulguru Sanskrit University Kalidas Government of Nagpur by the Maharashtra. The State Government has been requested to furnish necessary information in this regard and the same will be laid on the Table of the House, when received.

According to the information furnished by UGC, the Commission provides financial assistance to State Universities for purchase of books, journals and equipment, recruitment of staff, construction of academic buildings and hostels only after the concerned Universities have created infrastructure minimum appointed the prescribed minimum number of teaching and non-teaching staff, and fulfilled other essential conditions in accordance with the provisions of UGC Act and Regulations.
