Children adopted by foreign nationals

2584. SHRI MURLIDHAR CHANDRAKANT BHANDARE: Will the Minister of WELFARE be pleased to state:

- (a) the number of children adopted by foreign nationals and taken a road during the years 1990, 1991 and so far in 1992;
- (b) the number of children sent abroad for adoption during these years; and
- (c) the steps taken by Government to protect the interests of these children against exploitation and abuse?

THE MINISTER OF WELFARE (SHRI SITARAM KESRI): (a) As per the existing law, no foreign national can take an Indian child in adoption straight away. Rather, after following the due procedures, the child is given in guardianship to the prospective foreign adoptive parent for eventual adoption as per the law of the land in the concerned foreign country.

- (c) The foregn enlsted agencies through whom prospective foreign adptive parents send their tions are required to send quarterly progress reports of these children for the fire two years and half-yearly progress reports for the next three years to CARA through the respective Commission Embassy|High and also to the court which guardianship passed the original order.
- (2) lists of children who have been given in guardianship for adoption to foreign nationals, are regularly

sent to India's diplomatic Missions abroad for keeping an unobtrusive watch over the progress and welfare of these children.
