#### Rehabilitation of scavengers

2578. SHRI S. S. AHLUWALIA Will the Minister of URBAN DE-VELOPMENT be pleased to state:

- (a) whether it is a fact that Govern ment have decided to ban dry latrines in the country;
- (b) if so, whether Government have done any survey about the persons who earn their livelihood by scavenging;
- (c) if so, what are the details thereof;
- (d) what is the number of scavengers in the State of Bihar; and
- (e) the manner in which Government propose to rehabilitate these scavengers of Bihar?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI M. ARUNA-CHALAM): (a) Yes, Sir.

- (b) to (d) There are no precise estimates about the number of scavengers in the country. However, based on the survey conducted by the National Sample Survey Organisation, the Task Force constituted by the Planning Commission in July, 1989, in its Report on 21st March, 1991, has estimated the number of scavengers for the year 1989 as about 4 lakhs. Based on this estimation prepared by the Task Force, the number of scavengers in Bihar as in 1989 was 22,389.
- (e) A rapid survey to Identify each individual scavengers and his dependents and their aptitude for

specified alternative trade and occupations is in progress. It is proposed to rehabilitate the scavengers and their dependents during the 8th Five Year Plan in alternative and dignified trades and occupations through self-employment schemes. The existing training schemes of the Central and State Govt. are being designed for scavengers. The foucs will be of developing/upgrading skills for self-employment. Central assistance is being provided for rehabilitation of the scavengers.
