in April, 1992 to step up the allocation of wheat from he Cenfal Pool to one lakh onnes per month. Keeping in view the sock position of wheat in the Central Pool and o her rela ed factors the allocation of wheat to the State has been increased from 60,000 tonnes in April, 1992 o 65,000 tonnes per month from May, 1992.

- (d) and (e) There is no doubc that the processing of sugarcane

through Khandsari and Jaggery Units is an inefficien way of uti-lisa ion of sugarcane as compared to vacuum pan process of manufacture of sugar from sugarcane. Keeping this in view, the Governmens has already taken steps (o increase the licensed and ins ailed capaciries of the vacuum pan process sugar industry. -However, the Jaggery Industry plays a sigtrficani role in the rural economy of our country and jaggery is an importani item of consumption .speciall) amongs the rural people.
