

**Demand for upgradation and increasing the number of Trauma Centres  
at all the National Highways**

SHRI A. ELAVARASAN (Tamil Nadu): Sir, I would like to bring to the notice of this august House a very important matter. There is an urgent need to increase the number of Trauma Centres and upgrade existing Trauma Centres at National Highways. Our country has registered the maximum number of deaths in road accidents in the world. The latest statistics collated for the year 2007, show that the number of road accidents is 4,18,657 with fatalities 1,14,590. Despite the rising number of road accidents and fatalities, the Government does not seem to be too bothered about road safety issues. While the budget allocation is in thousand crores for various projects and programmes, the allocation is only in crores, in two digits for road safety and, unfortunately, this fund, for the last three years, has not been fully used. For example, the Government earmarked Rs. 47 crores in the year 2006-07 for road safety but only Rs. 43.25 crores were spent. The number of deaths has increased especially due to failure of providing immediate treatment to those who are affected by the road accidents. Therefore, I request the Government to treat road safety as an important category, like agriculture, health, employment, etc., and take immediate steps to increase the number of Trauma Centres and upgrade the existing Trauma Centres at all the National Highways with necessary ambulance facilities and introduce a three digit phone number for help just like 100 for police and 101 for fire service so that the number of road accidents and fatalities could be reduced considerably, at least, in future.

**Demand to open Nathula pass in Sikkim for tourism**

SHRI O.T. LEPCHA (Sikkim): Nathula Pass on the Indian and Chinese border in the State of Sikkim has been opened for limited trade purposes since July 2006.
