THE DEPUTY CHAIRMAN: Today, after a very long time we have got a Calling-Attention. I think everybody is in attention to start it.

RE. SUCCESSFUL LAUNCHING OF "PRITHVI"

SHRI JAGESH DESAI (Maharashtra) : Madam, only half a minute.

THE DEPUTY CHAIRMAN: Yes. . . . (interruptions) . . . Just a minute. I have identified Mr. Desai. I will call you. I have called Mr. Desai.

SHRI JAGESH DESAI: The other day 1 referred to launching of "Prithvi," and we are very happy that the most sophisticated missile "Prithvi" has been successfully launched. So, we all must compliment and congratulate all the technicians and those defence personnel and scientists who have made this possible. The whole House should join in greeting them. That is what I wanted to say, Madam.

SHRI MURLIDHAR CHANDRAKANT BHANDARE (Maharashtra) : I associate. The whole House associates.

SHRI SIKANDER BAKHT: (Madhya Pradesh): I associate with whatever Mr. Jagesh Desai has said on behalf of my party.

THE DEPUTY CHAIRMAN: The whole House associates and would like the Defence Minister to convey the sentiments of the House and congratulate everybody who is involved in it.

Shall we go ahead, now the "Prithvi" is over?

SHRI MOTURU HANUMANTHA RAO (Andhra Pradesh): Yesterday, Madam, you were in Chair. The entire House expressed its shock at three Harijan women being raped and murdered.

THE DEPUTY CHAIRMAN: That matter was raised yesterday. We cannot raise it again.

SHRI MOTURU HANUMANTHA RAO: We all pleaded for a statement by the Home Minister on that horrible incident. Has it been brought to his notice?

THE DEPUTY CHAIRMAN: You have raised that issue yesterday.

SHRI MOTURU HANUMANTHA RAO: Will he be kind enough to issue a statement on that?

THE DEPUTY CHAIRMAN: Mr. Hanumantha Rao, you are a very senior Member of this House. You know that once the matter has been raised. I allow ed it to be raised because it was about women, Harijan women. They were raped, and it was a serious matter. The Parlia mentary Affairs Minister was here. He said that they would find it out. I am sure, they would do it...........(Interruptions)

Now 1 have got other business. Yes, Mr. Fernandes......(*Interruptions*)

No, we cannot raise it again and again. You know the procedure of the House that a matter which has been raised on the floor of the House once, should not be raised again the next day. Please, no.

Yes, Mr. Fernandes.

SHRI SHANKAR DAYAL SINGH (Bihar): Madam, one minute.

THE DEPUTY CHAIRMAN: No. I have asked Mr. Fernandes to speak.

SHRI JOHN F. FERNANDES (Goa): Madam, I stand up for the same matter which was raised by my colleague, Mr. Jagesh Desai.
