To improve the profitability, Indian Airlines has taken several other steps, such as improved utilisation of A-320 fleet, savings in administrative expenses, control on recruitment of staff, pre-flight checks to avoid wastage on food upliftment on board, etc. The net loss sustained by Indian Airlines during the last three years is as follows :—

1989-90—(Rs. 15.24 crores). 1990-9—(Rs. 64.59 crores). 1991-92—(Rs. 211.55 crores estimated).
