(b) if so, what are the avenues for promotion of these Class-IV employees to Class-IH ;

(c) whether any quota of Departmental promotion of these, employees has been fixed, if so, the details thereof and if not, the reasons therefor; and

(d) in what manner Government propose to improve the service career prospects of those employees ?

(b), and (c) Bearers have avenue of promotion to Group "C posts of Sales In-charge/Junior Clerk/Bill Issuer (Rs. 825—1200,) and Stores-cum-Accounts Clerks (Rs. 950—1500), from where they can progress in the cadre of Catering Managers where at the level of Asstt. Catering Managers' a quota for promotion has been fixed and then right upto the post of Chit ..Catering Manager (Rs. 2000—3200). etc.

(d) Avenue of promotion available to Bearers are considered adequate.

#### **Book Stalls on Indian Railways**

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MAL-LIKARJUN) : (a) Yes. Sir.

(b) and (c) In 1967, it was decided to delete the clause of "Automatic renewal" from the agreements of M/s A. H. Wheeler and Co. and M/s Higginbotham but to extend their period of agreements from 5 years to 9 years.

#### **Reduction of Posts of Officers in Railways**

(a) whether it has been decided by Government recently to reduce 20% post of the higher grade officers in all the departments of Zonal Railways including Railway Board so as to reduce the expenditure thereon ;

(b) if so, what is the number of posts of Dy./Jt. Directors/Directors and Executive Directors that have been reduced from each Directorate of the Railway Board ; and

(c) the time fixed for implementation of the above decision ?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MAL-LIKARJUN) : (a) The Ministry of Railways have decided to keep the operation of a certain number (not 20%) of higher grade posts in abeyance as an economy measure.

(b) and (c) The following six posts have been held in abeyance, namely (i) one Member of the Railway Board (ii) Executive Director, Vigilance (Accounts) (iii) Joint Director (Training & Manpower Planning) (iv) Joint Director (Safety) (v) Railway Liaison Officer and (vi) Joint Director (Computerisation & Information Systems).
