SEZ in Saurashtra, Gujarat

- (a) whether Government have received any applications from the Government of Gujarat/Members of Parliament and other Organizations to setup Special Economic Zones (SEZ) in the Saurashtra area;
 - (b) if so, the details thereof; and
 - (c) the decision taken by Government in this regard so far?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (DR. RAMAN SINGH): (a) to (c) A Special Economic Zone is already functional in Kandla in Kutch region. Further, approval has been given for setting up of a Special Economic Zone (SEZ) at Positra in Saurashtra on the basis of proposal received from M/s Gujarat Positra Port Infrastructure Ltd. and supported by the Government of Gujarat. There is no other proposal pending with the Central Government for setting up of any other SEZ in Saurashtra region of Gujarat.

Special export promotion package

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (DR. RAMAN SINGH): (a) to (d) Yes Sir. A number of measures have been taken to boost exports which include reduction in export credit rate for both pre-shipment and post-shipment, special interest rate package to manufacturer exporters with an export contract of Rs. 100 crore or above for a period of one year from October 2001, extension of normal repatriation period from 180 days to 360 days for exports made to Latin American countries for a period of one year, upward revision of drawback rates, removal of value caps under the DEPB Scheme and extension of the export obligation period by six months.

(e) An accurate assessment of the impact of war in Afghanistan on our marine exports can be made only on receipt of export data for October and November, 2001. However, the September 11, 2001 incidents in USA have affected our marine product exports as is evident from the export data given below:
