

**Funds from centrally sponsored schemes**

1624. SHRI CHANDRA MOHAN SINHA : Will the Minister of WELFARE be pleased to state :

(a) what are the criteria for allotment of funds under the centrally sponsored schemes ;

(b) the details of the amount allotted during the year 1990-91 and 1991-92, under these schemes, statewise; and

(c) whether the allotment for Orissa has been utilised in full during 'the last two years and if so, under which schemes and what are the achievements thereof ?

THE MINISTER OF WELFARE (SHRI SITARAM KESRI): (a) Different criteria were followed for sanctioning grant-in-aid and release of funds under different schemes.

(c) whether all this was authorised by the Government of Jammu and Kashmir or by the concerned adviser to the Governor; and

(d) what steps are proposed to be taken to retrieve the said property and the said amount ?
