THE MINISTER. OF. HUMAN DEVELOPMENT RESOURCE (SHRI ARJUN SINGH): (a) to (d) Delhi Administration has intimated that a competitive test was held on 24-3-91 for selection of TGTs. The cut off marks for SC/ST candidates were lower than those for the general category candidates and these were further relaxed to cover more SC/ST candidates. The eligibility requirements for the post as indicated in the advertisement was a degree in the concerned stream i.e. Arts/ Commerce/or Science from a recognised University and Diploma/Degree in teaching/Education and the age limit was 18---30 years relaxable upto 5 years in the case of SC/ST candidates. Delhi Administration has also intimated that against a total requirement of 383 vacancies for SC and 260 for ST, 329 and 64 SC and ST candidates respectively were selected for the posts of TGT. The backlog of vacancies is 54 and 196 for SC and ST respectively

Employment for minorities under 15-Point Programme

Point Nos. 11 and 12 relate to the Department of Education.

Under Point 11, which relates to Community Polytechnics, during the last 3 years, the total number of persons, including minorities, that were trained was 95,000. About 39,000 were employed/self employed. Under Point No. 12, which relates to the UGC Scheme of Coaching Classes for competitive examinations, there were 12,776 persons who received such coaching during 1988—91. About 1200 persons qualified in various examinations.

Urdu medium Schools under M.C.D.
