will destroy incentives to manufacture; (c) a twenty year term of patent will result in delaying introduction of new products; (d) research and development would become redundant; (e) Indian exports of such products would be affected; (f) patent protection on bio-technology will have adverse consequences on preventive medicine; (g) automatic licences of right are needed to bring about competition.

Government is examining all aspects of the compromise proposals of DG GATT for taking a final view.

The proposals of DG GATT are not in the nature of a "Leave it or accept it as it is" proposal. Some major participating countries have expressed less than full satisfaction with the proposals and have indicated a willingness to carry forward the negotiating process on the basis of these proposals.

India also intents to seek improvements in the proposals. Hence, the question of consequences of accepting or rejecting the proposals does not arise.
