**Demand for assistance to Goa to face likely terrorist attack**

SHRI SHANTARAM LAXMAN NAIK (Goa): Madam, there are reliable reports that Goa may be the next target of the terrorists. The sea coast of Goa which is 104 kilometers, having a number of five star hotels, is vulnerable. Besides, thousands of tourists enjoy nature's beauty, walk along the sea coast during the peak season of December and January.

The Central Government has to step in to give Goa Police a crash course which should be organised by the Home Ministry immediately. Further, bullet-proof jackets, AK 47 rifles and vehicles have to be dispatched to Goa on a war footing.

It has to be admitted that most of our police force, and for that matter, in most of the States, are not trained to face deadly terrorists, it takes time for the National Security Guards to reach the place under attack, and therefore, the State police are to be trained at least to the extent of holding the fort till the arrival of the NSG forces.

Christmas and the New Year Festivals are round the corner in Goa. If the tourists are convinced that enough security arrangements are made, then, there may not be further cancellation of reservations of which reports are daily pouring in.

The Central Government should extend a financial package for a smaller State like Goa to purchase sophisticated weaponry, gadgets, vehicles, speed boats etc.

The Defence Ministry has to give the Navy and the Coast Guards necessary instructions to keep constant vigil on our sea coast and intercept suspicious vessels and minutely scrutinize the documents produced by them, lest we are not taken by surprise. Thank you.
