Considering the difficulties faced by the deep sea fishing industry during the period 1987 to 1990, the Government, in April 1991, have announced a scheme for rehabilitation of sick but viable fishing units, which is being implemented by the Shipping Credit and Investment Co., of India, Bom-A number of cases for rehabilitation under the above scheme have since been approved. Requisite will be available to these units as soon as they complete the necessary formalities.
